

#### IRS IMPERSONATOR SCAM

The scam: The caller says they're from the IRS, and you owe taxes. They claim you must pay immediately. The caller might threaten you, saying the local police will arrest or deport you if you don't pay right away. They



may also say your driver's license will be revoked. The caller may have some information about you, including your Social Security number or Federal Tax ID number. They want to make you think it is the IRS calling you. But it's not the IRS. If you get a call like this, you can be sure it's a scam.

#### What to know:

- The IRS will not call you about your taxes unexpectedly. If you owe taxes, the IRS will contact you by mail.
- The IRS now has private debt collectors who might call you, but only after you've received two letters in the mail about your debt: one from the IRS, followed by one from the debt collector.
- A private debt collector working on behalf of the IRS will never ask you to pay over the phone. The IRS has guidance on private debt collection and answers to frequently asked questions.
- The IRS and its debt collectors won't demand that you wire money, pay with gift cards, pay with cryptocurrency, or send cash.
- Neither the IRS nor its debt collectors will threaten to arrest you.

#### **GOT A CALL?**

**Don't give the caller information** such as your financial or other personal information.

Write down details such as the number and name of the caller.

#### Hang up.

**Contact the IRS directly.** If you think you may owe back taxes, call the IRS at 800-829-1040 or visit the irs.gov website.

#### Report the call.

File a complaint with:

- the Treasury Inspector General for Tax Administration (TIGTA) at tigta.gov to 800-366-4484
  - the FTC at ftc.gov/complaint or 877-FTC-HELP

- eCS Electronic Customer Service: Real-time credit card information, including transactions, pending activity, payment information, statements, custom e-mail alerts, plus you can sign up for e-statements and reenroll for online access at: www.trailnorth.com
- EMV Chip and Contactless Transactions Your new card will include the latest chip technology, including support for contactless transactions.
- **Safe and Secure** Every chip and contactless transaction includes a unique code, helping to protect against fraud and keep your information safe.
- **Contactless Card Symbol** Look for the contactless symbol on the payment terminal. Save time every time you tap.
- CardValet Manage your card usage through your mobile device by identifying where and how your TrailNorth credit card can be used.

We will send you a letter before your card is mailed asking you to be on the lookout. This letter will cover additional details like activating your card, accessing rewards from your current card, accessing your new reward offers, and an FAQ.
